



ACTIVITY RELEASE OF LIABILITY & PHOTO RELEASE

3.0 I agree to indemnify and defend GetKnit, LLC against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of the Facilities or participation in the Event.

4.0 Additionally, as a participant I hereby authorize GetKnit, LLC and the Facilities to take photographs of myself, the Participant and to use or publish such photos (either still photos or film/video) as they see fit and I *wave any rights and any claims I might have regarding the taking or publishing of any such photos.*
